B. Executive/Committee Reports

1. President

- 2nd Vice-President-I have appointed Jim Turner to replace Kevin Walker as 2nd VP as he was the previous 2nd VP.
- Remedy-Discussions are taking place with teachers who have remedy. It is a month-to-month calculation so if a teacher's class becomes non-compliant mid-month or even the end of the month they are entitled to remedy for the whole month. It's important for staff reps to let teachers know to inform them if there has been a change in their class size or composition so the remedy calculation, if needed, can be figured out appropriately. If a teacher has chosen more prep time as their remedy, BCTF believes that the teacher should NOT have to plan for their prep time and if it is a TTOC being called in, then the TTOC is informed that there will not be a plan for that block and they should have something prepared. If teachers are taking half-days or full-days off as remedy and planning for those days, then this is not prep time but time in-lieu and would need to be agreed upon by both the district and union.
- SURT-We had a staff union rep training on Oct. 24th with Jim Iker as the facilitator. It went well. One of Jim's suggestions were for staff reps to hold monthly staff committee meetings. These meetings would be short, about 10 minutes, and it would be a chance to discuss any issues/concerns at the school. One of the first topics that was suggested was a discussion on Natural Justice and the BCTF Code of Ethics as we have a lot of new stuff who might not be familiar with them. Planning to have a SURT for Health and Safety Reps in January and another one for Staff Reps in February.
- District Ratios-We were short in Teacher-Librarians and Counsellors. They posted a 0.2 Teacher-Librarian position, and they added a counselling block to TREC.
- If you are short TTOCs, please let me know ASAP.
- BCTF is doing a province wide survey on violence. Please encourage members to complete the survey at <u>bctf.ca/bvsurvey</u>. They will be doing one on Full-day Kindergarten in January.
