1. President

New contract: \$12 million in teacher mentorship. Salary increase 2% for three years and an extra 1% at the top of the scale. Able to port 20 years seniority on a go-forward basis. Up to another 1% salary increase based on savings from streamlining the grievance process. Salary is retro-active.

Return to in-class instruction

Return June 1. K-5: max 50% of students in a class, attending 2 days a week. Friday is for online learning. 6-12: attendance 20% of the time. ESW (essential service worker) children and vulnerable Students can attend all 5 days.

2. Pro-D

Individual account: \$62,833.13. TTOC days given 130, used/reserved 76, days remaining 54. District account \$1,571.77

3. Treasurer

Assets: \$260,146.56: Chequing \$187,140.21; Savings \$73,006.35. Lynne applied for almost \$10,000 in grants from the BCTF. Expenses are lower due to COVID.
