Harrison – No report

SEA/TTOC shortage – Unqualified staff could fill in for a year. Admin has been reluctant to use this emergency measure.

Local bargaining: ratification – Article E2.4: Non-discrimination language - passed Mentorship – There is money left to start new mentorship relationships

2) Pro-D Chair -

There is \$60,000 and \$26,000 with \$11,000 on reserve. 65.5/100 of TTOC days used.

Discussion about moving the November Pro-D day to another date.

Discussion re the content of the District Pro-D Day. Kathy and Lynne will be meeting with the Superintendent.

District admin are questioning how teachers are held accountable for pro-d activites.
